PRESIDENT'S REPORT

2015 - 2016

It is with great pleasure that I present the Southwest Advocacy Association (SWAA) annual report for 2016. As with last year, we have overcome challenges thrown at us regarding funding, service delivery and relocation. Despite these issues, SWAA has continued to provide consistent provision of advocacy services throughout the Southwest of Victoria since 1993.

Disability advocacy recognise the rights of all people with disability to live in the community, with choices equal to all others. At SWAA, we are dedicated to promoting the human rights, fundamental needs and value of people with disabilities living in our Warrnambool and the Southwest. I have the utmost confidence that SWAA will continue to provide a first class response to disability advocacy to Southwest consumers and ensure consumers receive the appropriate support and care to ensure their wishes and opinions are valued and their needs are being appropriately met.

We have experienced some changes this year, in particular relocating to our most recent and hopefully long term premises at 45 Hider Street Warrnambool. The new building offers much needed office space, ample parking and access for both our staff and consumers. An official launch is planned for the near future.

The NDIS is scheduled to be launched in the Southwest region on 1st October 2017 and holds a wealth of unknown factors as to how this new scheme will adequately support the needs of eligible consumers. Informed choice and greater control for consumers is vital in receiving the program as this provides people with the right to determine their own future.

SWAA continues to provide an optimum service promoting the role and value of independent and systemic advocacy to people who live with disability and this could not be achieved without the dedication of our wonderful staff. On behalf of the Committee of Management, I would like to thank Executive

Officer Adele Markwell, advocacy worker Roz Rantall and administrative officer Margaret Gottlewski for their continued passion, hard work and commitment to SWAA and its consumers. Adele's ongoing pursuit for funding and lobbying to both state and federal governments for additional financial support, demonstrates her commitment to SWAA. Roz and Marg are also invaluable members of our team and their hard work, expertise and individual skills are very much appreciated by the Committee.

Finally, I would like to express my gratitude to our wonderful Committee of Management: Mark Barling, Mark Powell, Rose Edgerton, Cheryl Gould, Colin Vale, Peter McMahon and Andrew Harmon. Their collective expertise, experience and commitment to SWAA is very much appreciated and I thank them for their continued support of SWAA.

EXECUTIVE OFFICER'S REPORT

2015 - 2016

The last 12 months has seen Southwest Advocacy Association Inc. coming up against all the same challenges as we have for the past 23 years. Inadequate funding is an ongoing battle for us and takes up more of my time than should be necessary. I will continue to put adequate funding on our wish list for things that would make our job so much easier by freeing up time to spend doing the thing that we are funded to do, advocating for the people in the southwest region with disability.

Just over three years ago we were forced to relocate due to our premises being sold. This was disappointing for us after ten years in the Princess St location and it is always difficult to find premises that meet our needs for a price that we can afford. Unfortunately we fairly quickly realised that the premises we took, although perfectly located, was not really suited to our needs but we were locked into a three year lease. I started looking for an alternative location when our lease was coming up for renewal and was very fortunate to find our current location at 45 Hider Street. We moved in in May and this location is perfect for our needs. It meets all the requirements of a service such as ours and I am very hopeful that we will be here for a long time to come. If our service needs to grow a bit with the introduction of the National Disability Insurance Scheme in our region, we have space to do so. Although no-one ever really complained about the cramped conditions in the old premises, I think our little staff are much happier in our new home and most importantly the people who use our service have the privacy that is integral to the success of our service. I am no longer located in the kitchen so Marg and Roz don't have to plan their coffees or lunch around whether I have someone in my office/kitchen.

I have written about the impending arrival of the National Disability Insurance Scheme in this report for a number of years now and now we are under 12 months away from the roll out here in South Western Victoria. There will be much work in preparation for those big changes for people with disability and

their families and carers and I am hopeful that by the time it gets to us the problems being experienced in the areas where the roll out has already happened will have been rectified. My understanding is that the problems have occurred due to new technology. The NDIS is something that we have been waiting for for many years so we are all hoping it will give people with disability and their families and carers the care that their life requires. It will be interesting in a couple of years' time when the roll out is complete to see how we all feel about whether or not it is a success. I am thinking that there will be many people who have great experience and others who do not.

We have had another full audit this year and I am very pleased and proud once again that we have come through with flying colours. I know that as an organisation we have great management from a very dedicated Board and I always know that we are operating according to the rules but it is always a relief when our audit is complete.

Speaking of our Board, I thank them for the support that they give me throughout the year. I know that it is difficult at times to be able to get to the meetings and attend to issues outside of our meetings but they are always there to assist and support me and I thank them very much for that. They are a very dedicated group of people and Southwest Advocacy would not be the successful service that it is without them. I am very grateful to them all.

All Abilities Advocacy continues to run very smoothly and is consistently having great attendance at the meetings. Kylie continues to do a fantastic job of making the meetings interesting and informative and has this year concentrated a lot of attention on the NDIS.

Marg continues to run our office with great skill and efficiency and I know our service users appreciate her friendly and helpful voice over the telephone. I certainly appreciate her ability to always have any information I need at her finger tips.

Roz continues to manage the difficult job of only working one day per week and I appreciate her ability to manage her work load within these restrictions.

We all appreciate very much Judy's care for our premises. She always has the place looking great.

As we draw towards the end of 2016 I wish all our Staff, Board, service users and members a very merry Christmas and a happy new year and we will see them all back in 2017.

Qualification

Our audit of the *Southwest Advocacy Association* was limited in that opening balances and income and expense accounts were taken from an externally produced report. This resulted in varied treatment of some transactions. In addition the use of back-dating cheques to recognise expenses in prior periods is not appropriate policy.

- 4. The Southwest Advocacy Association 2014/2015 Annual Report shows both ATO Creditors for PAYG and GST amounting to \$2353.00 and Trade Creditors of \$4332.00. Included in the amount of \$4332.00 is the \$2353.00 owed to the ATO and therefore has been incorrectly shown twice. This amount has been taken to an equity account to correct the balance sheet.
- 5. We inquire as to why Southwest Advocacy Association pays the net wage of a Warrnambool and District Food Share employee. We have no basis for reconciliation from the ATO of said wages and we feel it would be prudent that these wages be paid directly by Warrnambool and District Food Share.
- Account Reconstruction. We have reconstructed the accounts from the balance sheet and profit and loss statements.
